KM still awaiting a full response from PJ but he had suggested that all club full time employees were already above this rate (suggesting that part time staff such as programme sellers, food and beverage staff etc.may not be) Both KC and PJ have taken on board our suggestion that companies in the club's supply chain should also comply as and when major contracts such as Compass come up for renewal. Jon Day had contacted Councillor Phil Bradbury who expressed a willingness to attend meetings with the club as and when necessary.
